Change of School or Programme

- The student is permitted to request to change his/her school of study within two weeks from start of their first registration.
- The student is permitted to request to change his/her programme of study up to week 9 of semester two.
- Changes to school or programme require the permission of the head of school and University Registrar.
- Students must meet the admissions requirements of the new school or programme.
- In case of common modules Students will be granted exemption from relevant completed modules if they achieved a pass grade.
- All exemptions must be approved by the Head of School.

Change Programme Cycle

Student submit the change programme form with his/her signature and the reason for transfer and any other information that may support his/her request.

(students are required to meet with the Head of new school to discuss the proposed transfer prior to completing and submitting the change of programme school transfer.)

Student Services Approval

(Student Services confirmation that the student meets the conditions and requirements of the new programme of study or specialism.)

Head of School of Current Programme Approval

(to notify the Head of School with their request to add any comment if needed.)

Registrar Approval

(to ensure changes will be implemented.)
